ACTION TAKEN REPORT

A complaint was received by West Bengal Human Rights Commission from one Shanwaj Kabir, S/o. Samsuddin Mondal, Vill. & P.O. Birpur, P.S. Nakashipara, Dist. Nadia on May 6, 2014 alleging illegal detention of Alamgir Kabir @ Rintu, S/o. Samsuddin Mondal of Vill. & P.O. Birpur, P.S. Nakashipara by S.I. Raja Sarkar, Officer-in-Charge of Nakashipara Police Station.

The Commission taking cognizance and hearing the matter passed the following recommendation:

- I. The departmental proceeding initiated by Supdt. Of Police against S.I. Raja Sarkar should be completed at the earliest and the result informed to the Commission.
- II. A sum of Rs. 5,000/- (Rupees five thousand) only may be deducted from the salary of the S.I. Raja Sarkar and paid as compensation to Alamgir Kabir @ Rintu, s/o. Late Samsudding Mondal, Vill. & P.O. Birpur P.S. Nakashipara, Dist. – Nadia and the same be informed to the Commission.
- III. The Commission appreciates the fact finding report of Shri S.M. Azim, Dy. S.P. (D&T), Nadia and requests that the same may be published by D.G.P., West Bengal in West Bengal Police Gazette.
- IV. The Commission also appreciates the initiative taken by Shri Sabyasachi Raman Mishra, IPS, Superintendent Of Police, Nadia in taking firm departmental action against S.I. Raja Sarkar.
- V. The Commission requests the Home Department that a message may please be sent to all the O.C. of Police Stations through Director General of Police that such illegal acts of

detention should not be done which led to gross violation of Human Rights.

By his letter dated 11.01.2016 the Special Secretary to the Govt. of West Bengal, Home Department, Human Rights Branch informed the Commission as follows:-

"In drawing your kind attention to the above noted subject and references, I am directed to send herewith the copies of Memo No. 6277-Adm/HRC, dt. 02.12.2015 as received from Director General & Inspector General of Police, West Bengal along with its enclosures in which it has been informed that appreciation of West Bengal Human Rights Commission to Sri S.M. Azim, Deputy Superintendent of Police (D&T), Nadia and to Sri Sabyasachi Raman Mishra, I.P.S., Superintendent of Police, Nadia has been communicated and also published in Bengal Police Gazette.

The Director General & Inspector General of Police, West Bengal has also informed vide their Memo dt. 02.12.2015 that direction to all Officer-in-Charge of Police Stations for not to do illegal detention which leads to gross violation of Human Rights has also been communicated.

This is for favour of kind perusal of the Commission."
