KOLKATA: Apprehending that demonetisation is likely to affect Gangasagar Mela this year, district administration is taking adequate steps to ensure the pilgrims enjoy a cashless mela.

"Gangasagar Mela Mobile App is being introduced for the first time by the district administration. It will be officially launched on January 3 by chief minister at Nasama," said an official.

allegedly administered potas-sium chloride injection through
intravenous fluid (IV) by a nurse
at Park Clinic on September 29.
The infant's parents have
urged chief minister Manata
Banerjee to shut down the private hospital as exemplary punishment until a full investigation
is done.

cimic on September 28 with mild dehydration and symptoms of vomiting. According to medical experts, concentrated potassium chloride can be fatal if it is injected. Avighna's father. Monojit Saha, has lodged an FIR against the nursing home and Dr AK Paul and the nurse Poonam Debnath at the Shakespeare Sarani police station on January 2.

"It is a case of medical negligence. My son's condition deteriorated after the nurse admiristered the potassium chloride injection. We have lodged an FIR against the clinic, Dr AK Paul and Poonam Debnath." Monojit said while spaeking to reporters on Tuesday.

is in a vegetative state due to medical negligence, "said Monojit.
People for Better Treatment (PBT), a non-government platform floated for the victims of medical negligence in the country has also written to chief minister Manutal Banerjee, requesting her to take action against the erring doctors and nurses of the clinic.
"The parents have briefed us. Exemplary punishment should be given to the doctors and nurses of the clinic. We have also written to the chief minister requesting her intervention. The licence of the clinic should be cancelled," said Dr Kunal Saha, president of PBT.
