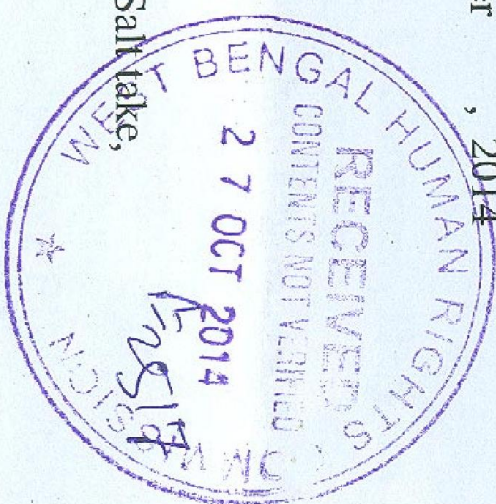

It was resolved that in order to efficiently execute the mandate of Conclave and to coordinate the decision of the Conclave, Hon'ble Mr.Justice Vijender Jain will be Convener of the Conclave till further decision.

1. Uniform terms and conditions of Hon'ble Chairperson and Members.

It was resolved in the Conclave to constitute a Committee comprising of Hon'ble Mr.Justice Bilal Nazki, Chairperson, Bihar State

Human Rights Commission and Hon'ble Mr. Justice Prafulla Kumar Misra, Chairperson, Goa State Human Rights Commission to look into the matter.

2. **Declaration of Hon'ble Chairpersons and Members of the Commissions to be treated as State Guests on reciprocal basis.**

It was resolved in the Conclave to request to National Human Rights Commission to have the names of National Human Rights Commission and State Human Rights Commissions included in the Warrant of Precedence. National Human Rights Commission be requested to send a request to the Ministry of Home Affairs for the said purpose.

3. **To make Human Rights Commissions more effective to carry out the mandate of Parliament.**
5. **Power to get the orders enforced – to effectively prevent violation of human rights.**
6. **Infrastructure – State Commissions to have an independent building for its offices and full time Secretaries and Inspector Generals of Police in terms of the mandate of the Act.**


It was resolved in the Conclave to constitute a Committee comprising of Hon'ble Mr. Justice Nisar Ahmad Kakru, Chairperson, Andhra Pradesh Human Rights Commission and Hon'ble Mr. Justice S.R. Bannurmath as Members of the Committee to discuss and deliberate on agenda items no. 3, 5 and 6 as stated above and present their recommendations.

4. **Annual holding of Conclave by the State Commissions.**

It was resolved in the Conclave to hold next Conclave of Human Rights Commissions either in Karnataka or Maharashtra. A Committee was constituted comprising of Hon'ble Mr. Justice S.R. Bannurmath, Chairperson, Maharashtra State Human Rights Commission and Smt. Meera C. Saxena, Acting Chairperson, Karnataka State Human Rights Commission to decide about the date of next Conclave with the consultation of the Convener.

It was also resolved in the Conclave that all the suggestions sent by different Human Rights Commissions will be considered by the respective committees.

The Conclave ended with the Vote of thanks.
